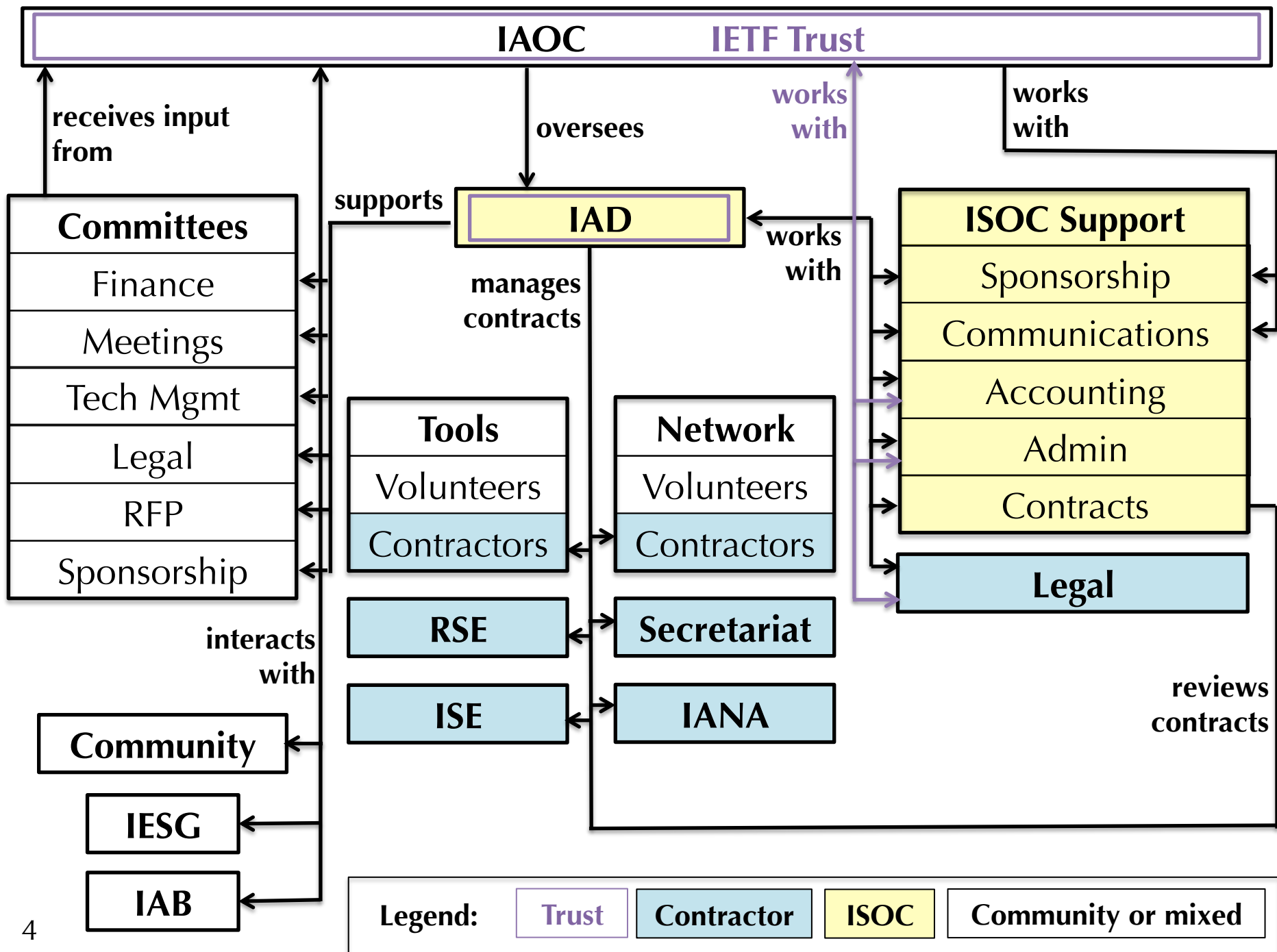


Introduction

- IETF Administrative Support Activity (“IASA”) created in 2005, documented in RFC 4071
- IETF community considering reforms to administrative arrangements (“IASA 2.0”)
- Outcome of IASA 2.0 discussion likely to impact both ISOC and the IETF
- Direction of IETF community discussion and its likely impact to become more clear in coming months

Reminder of how IASA works now

- IETF is an “organized activity of ISOC”
 - IETF has no independent legal status
- IETF Administrative Oversight Committee (IAOC), largely consisting of volunteers, directs and oversees IETF administration
- IAOC oversees the IETF Administrative Director (IAD) – single full-time ISOC employee
- Many, many more details ...



Why reform IETF administration?

- Many changes since 2005 within IETF, ISOC, and the world
 - Admin workload, staffing, budgets, fundraising, organizational directions, time commitments, etc.
- Challenges
 - Lack of clarity about responsibility, representation, authority, oversight (as between IETF, ISOC, and others)
 - Lack of volunteers, staff, and time
 - Lack of transparency
 - Mismatch between funding model and operating model
 - Rising costs

IETF community process

- IETF community discussion started last year
- Several working documents published covering history and current challenges
- Design team formed last week
 - Deeper dive into specific approaches
 - Exploration of issues outside typical IETF technical scope (budget, personnel, legal)
 - Goal: seed further community discussion around IETF 99 time frame (July)

Future steps

- IETF 99 time frame (July 16-21)
 - Design team output
 - Community discussion
- Agreement on approach and process within the IETF community
- Factor needs for additional budget, accounting clarity into 2018 IETF budgeting process (August)
- More detailed discussion with ISOC Board once IETF community direction is more clear
