#### **OVERVIEW OF THE PROJECT**

The *Community Technology Development Centers: Bridging the Digital Divide in Puerto Rico* Project has sustained the advancement and strengthening of community technology centers across Puerto Rico through capacity building, technical assistance, and alliance building. The project has supported the establishment and expansion of the Consortium of Electronic Libraries of Puerto Rico to maximize opportunities and to share resources, knowledge, and trends to reduce the digital divide.

The project has regularly implemented social media and other virtual promotional strategies to find new CTC's, recruit and train volunteers, identify funders and donors, and divulge the program's importance. The project began with 19 CTC's and currently has expanded to 28 CTC's. The Center for Puerto Rico will continue recruitment of CTC's with a solid team of administrators ready to work to increase free access to the Internet and other current technologies to geographically and socially marginalized communities.



## **DESCRIPTION OF ACTIVITIES**

During the reporting period, the project fulfilled its goals via the following objectives as stated in the proposal:

1. Strengthen CTC's network via [www.ctcpr.org](http://www.ctcpr.org) and other virtual platforms
  - a. [www.ctcpr.org](http://www.ctcpr.org) has continued to upgrade CTC information and added new educational resources. CTC administrators along with CPPR staff and AmeriCorps VISTA members will continue to provide content and support.
  - b. The Center for Puerto Rico and the CTCs continue to increase use of social media platforms like Facebook and Twitter in order to share program and local CTC happenings. The content includes photographs, videos, interviews, text notes, contact information, funding prospects, announcements, and other educational opportunities.
  - c. Publication of op-ed and columns on virtual and print media, including newspapers and blogs on issues pertaining to social media, the importance of CTCs, and free internet access. The articles shared opportunities, happenings and successes. The following articles were published during the last half of the project by CPPR staff, volunteers, and CTC administrators:

  2. Increase access to current technologies and the Internet in the CTCs.
    - a. This project began with 19 CTC's and currently has expanded to 28 CTC's. We are proud to announce that the Center for Puerto Rico has recruited 9 additional CTC's to participate in the new year-long cycle of the CTC Development Program that started in September 2014. Five (5) organizations were recruited in the Western region, including the municipalities of Isabela, Rincón, Mayagüez, Lajas and San Germán. Four (4) organizations were recruited in the Southern Region including the municipalities of Ponce, Yauco and Juana Díaz. The latter is one is a new region outreached.
    - b. Equipment such as cell phones, modems/routers, computers, and tablets, were donated by T-Mobile; most new or refurbished. Cell phones, tables and modems included one year of service with the company that provided text messaging, internet and unlimited phone calls throughout the island. Mobile phones and tablet devices were used for marketing and promotional services of the CTCs that integrated voice and text communication as well as photos and videos. The CTCs are regularly using Facebook®, Twitter®, and texting to share knowledge, fundraisers, special events, training opportunities, and provide general comrade volunteer support. Other equipment donated included a projector, Microsoft programs, and printers.
    - c. Center for Puerto Rico's staff has devoted 1,960<sup>1</sup> service hours in the last quarter of 2014 to support CTC's in their mission to provide free access to the Internet, computers, and educational support to CTC administrators. The service hours were devoted, but not limited, to:
      - i. coordination and promotion of educational sessions
      - ii. recruitment of CTC volunteers and administrators

- iii. identification of resources
  - iv. proposal writing
  - v. research on trends and models to manage CTC's and current technologies
  - vi. follow-up and technical assistance sessions with participants in person and via email, text, video conferences, and voice calls
  - vii. Implementation of volunteer recruitment strategies
  - viii. maintain software updates and connect printers and scanners
  - ix. support and provide strategies to expand programs and services to meet local community member needs
- d. See [www.ctcpr.org](http://www.ctcpr.org) for CTC locations and times where children and adults can access the Internet in Puerto Rico free of charge.

3. Increase knowledge and develop skills among CTC administrators

- a. A meeting took place on October 16, 2014 with staff from the Center for Empowerment and Free Enterprise (CEFE) at Universidad del Este to establish a collaborative alliance that will implement educational programs to develop computer skills among CTC administrators during 2015.
- b. A total of 3 workshops were provided during the reporting period, including:

4. Each CTC will achieve functionality and sustainability.

a. Of the 19 CTC's in the original proposal, 17 are providing free of charge programs and/or services to local communities, including tutoring for school children, access to internet to retired people, and skill development workshops. The CTC spaces are offered for rental and other community events that generate income to support programs and services. The remainder continued to be without services due changes in community leadership. The CTCs in the original proposal are:

- b. During the capacity building workshops and individualized technical assistance sessions, CTC administrators received new skills to develop proposals to receive funding for services as a strategy for sustainability. The following CTC's have received funding in support of their sustainability during 2014:
- i. Asociación Comunitaria Palmarejo II, Inc. in Lajas received \$20,000
  - ii. Comité Comunal de Corcovada, Inc. in Añasco received \$5,000
  - iii. Comité de Desarrollo y Conservación de la Comunidad Las Carolinas, Inc. in San Germán received \$8,000
  - iv. Comité Pro Desarrollo de Villa Cañona in Loiza received \$7,000
- c. In order to generate regular income to continue services and expand programs, CTC's have:
- i. developed sustainability components to generate income (short and long term) as part of their strategic planning
  - ii. copying, printing, and scanning services for a fee
  - iii. school supplies for sale
  - iv. educational programs at low cost
  - v. rent facilities for private events outside service hours

## **EVALUATION & DISSEMINATION**

- The data collected from the workshop's evaluations show that participants acknowledge that they gained new understanding on the subjects discussed during the workshops. Approximately, 82% of the responses report a lack of knowledge on the subjects presented at the workshops, while 96% reported having new ideas that are applicable to their projects and 97% as useful for the development of their CTC. Also, participants reported gaining new skills such as: development of promotion/marketing tools (flyers, social networks, brochures, etc.), funding proposals, evaluation and planning methods and strategies, techniques for establishing alliances through collaborative formal agreements; new awareness of the importance of a comprehensive administration plan for the CTC; carrying out evaluations; and so forth.



- Doctoral student, Ms. Yalitza Navedo, as part of a Social Policy Analysis course at the University of Puerto Rico in Rio Piedras, submitted the first evaluation of the CPPR's CTC program, including individual interviews with program staff and CTC administrators. The result of her internship project was titled “Informe evaluativo del programa de desarrollo de centros tecnológicos comunitarios” and was presented to CPPR staff in San Juan.
- Doctoral student, Ángel Duran, presented his thesis dissertation titled “La sociedad de la información y las Comunidades Especiales en Puerto Rico. Nuevas dimensiones de la marginalidad digital, 2000-2010” (Information Society and Special Communities in Puerto Rico: New dimensions on the digital divide, 2000-2010) at the Estudios Avanzados de Latinoamérica y el Caribe Program on December 5, 2014. Mr Duran’s research included a literature review on the issue of the digital divide, a history of the development of CTC’s during Sila M. Calderon governorship of Puerto Rico from 2001 to 2004, and interviews and visits to CTCs participating in this proposal.
- Estudios Técnicos, Inc. has offered to draft free of charge a complete evaluation of the program starting on 2015 in order to receive full qualitative and quantitative results since the Center for Puerto Rico Technology Centers Development Program began in 2011.
- Regular access to radio stations to promote events and opportunities and create a dialogue to discuss the importance of the CTC’s role in providing Internet and computer access and educational programs to develop community skills. Myrna Vazquez-CTC Program Officer, Juan Carlos Vega-Library Director, and the CTCs administrators have provided interviews in radios shows in Mayagüez and San Juan.
- The Center for Puerto Rico will continue to disseminate the CTC program achievements via annual reports, press opportunities, social media platforms, and special events.

## **CHALLENGES ADDRESSED AS REPORTED IN THE INTERIM REPORT**

- Many of the CTCs Administrators are volunteers and at times they have to relinquish their volunteer obligations for other opportunities that generate income. Nevertheless, the commitment of most of the participants is shown through their continuous participation in the Saturday 8AM – 12PM workshop sessions.
- The CPPR Library has committed its efforts to expand its educational programs outside the metropolitan area (San Juan) by hosting events in different CTC facilities. This allows for CTC administrators to minimize transportation costs while developing new skills and networking. This effort also reduces the cost of transportation to the participants that are from rural areas.



- The CTC administrators are in constant need of technical support due to low skills on computer management systems and limited experience using the Internet. The fast pace technology changes requires extensive technological support of the CPPR's Staff.
- The CPPR Library tried to establish (via e-mail) alliances with a CTC in Vietnam. The purpose was to share information regarding the CTC's challenges & opportunities. However, this alliance was never formalized. The CPPR Library wishes to engage contact with CTC's in Mexico to video chat and network among Administrators in an International level.

## **OUTCOMES & ACHIEVEMENTS**

The following activities and efforts of the Project showed successful outcomes:

- The establishment of a network of community leaders working towards reducing the digital gap in Puerto Rico. Communities are represented in a total of 18 municipalities in the West, East, South and San Juan Metro regions as shown in the map included in Appendix 3. The Center for Puerto Rico continues to expand CTC development by identifying new localities managed by volunteers willing to be trained as administrators.
- The website [www.ctcpr.org](http://www.ctcpr.org) is a place where anyone in Puerto Rico can identify CTCs that provide free Internet access and other new technologies.
- The 4<sup>th</sup> CTC Summit of Puerto Rico gathered 129 participants, proving to be a success. This event brought together government, academia and local communities determined to provide free Internet access to the general public and understand how poverty contributes to the digital divide. The event promoted alliance building, sharing of experiences, identify trends, and a sense of a support network from many communities around the Island.
- Several Electronic Library Consortium members have exceeded all expectations of leadership, volunteer work, and commitment during the year. Many of their current efforts are the results of the support and technical assistance provided by the CPPR personnel. For example:
  - Mrs. Irma Bartolomey, a CTC administrator in Rincón, accepted the challenge to offer two Twitter workshops that provided implementation strategies for use among CTCs. The following daily model for Twitter posts was developed by Mrs. Bartolomey and is being promoted for use among all CTC's:
    - Mondays to post events and weekly promotions
    - Tuesdays to highlight CTC staff and recruit new volunteers
    - Wednesday to share valuable new resources and technological trends, as well as relevant Twitter and Facebook pages
    - Thursday to share positive stories happening in the community
    - Friday to thank sponsors and funders



- Mr. Joe Santiago, a CTC administrator in Lajas, provided a workshops for CTC's and other organizations to aid them in the process of proposal writing for annual local legislative funds. He continues to bring issues regarding the digital divide, electronic libraries, and Internet access as one of the moderators in *La Comunidad Informa* Radio Show. Moreover, he constantly promotes events and activities from other CTC's and community initiatives
  - Virgen García, Irma Bartolomey, and Juan Vargas, CTC administrators in San Germán and Rincón, respectively, accepted the invitation to moderate the afternoon concurrent sessions in the 4<sup>th</sup> CTC summit. The educational sessions included presenting the workshop's resource among peers, managing the Q&A sessions, and distributing and collecting the evaluations.
- The Program effectively train 19 teams of CTC administrators to manage services and programs.
- This funding opportunity, to bridge the digital divide among 19 CTC's, has expanded to 28 CTC's. The Center for Puerto Rico has recruited 9 additional CTC's to participate in the new year-long cycle of Technology Center Development Program that started in September 2014. Five (5) organizations were recruited in the Western Region, including the municipalities of Isabela, Rincón, Mayagüez, Lajas and San Germán. Four (4) organizations were recruited in the Southern Region including the municipalities of Ponce, Yauco and Juana Díaz. The last one, is a new region outreached for the program.
- Integration of CTC's as spaces to provide workshops and webinars, which prepares administrators to integrate technologies, manage logistics, and expand educational opportunities for users and administrators.
- Direct engagement of the Puerto Rico government to support CTCs across the island. Some of the government offices where we have held meetings include: the *Junta Reglamentadora de Comunicaciones de Puerto Rico* to provide free Internet connectivity and the *Office of Special Communities* to include CTC's in the E-Rate Federal funding opportunity for 2016 that provides free Internet to libraries and schools. These important collaborations and alliances will expand Internet connectivity and infrastructure to decrease the digital divide.
- Full integration of Center for Puerto Rico AmeriCorps VISTA members Program to provide support, technical assistance, and recruit CTC administrators. The following members contributed since July 2014:
  - George Rivera: supports 10 CTCs members of the Electronic Library Consortium located in the San Juan Metro and East Regions of Puerto Rico.
  - Yina Reyes: supports 4 CTC's recently recruited in the Southern region of Puerto Rico.



- Maria Tirado: provided support to 5 newly recruited CTC's in the Western region of Puerto Rico.
- Jhosmayra Trinidad: provided constant communications, promotional materials, social media support, and public relations support to CTCs and on issues pertaining the reduction of the digital divide.
- Gloria Cordero: provided logistical, promotional, and technical support during workshops provided by and at the CPPR Library.

## **FINANCIAL REPORT**







### Los centros tecnológicos

---

En las comunidades existen ciertos nichos que necesitan atención para lograr equilibrio. Los centros tecnológicos brindan la opción de satisfacer las necesidades de acceso a las tecnologías de la información y la comunicación en las comunidades por lo general desaventajadas.

Estos lugares de transformación comunitaria son espacios para trabajar diversas áreas que conduzcan al mejoramiento de la calidad de vida y reducir la brecha digital. Es en estos centros donde surgen soluciones a muchos de los problemas o situaciones que aquejan a la comunidad, ya que ,además de brindar acceso a tecnologías, también se crean programas y servicios, y se convierten en espacios generadores de cambio social. Se trabaja entonces en la diversificación de servicios integrando a las diferentes generaciones que componen la comunidad.

La brecha digital es mucho más que la falta de acceso a la tecnología, es la incapacidad para utilizarla. Reducimos la brecha en la medida en que apoderamos a la comunidad de esos espacios y del uso proactivo de los mismos. Como empresas sociales, los centros tecnológicos son más efectivos



cuando son dirigidos por la comunidad y se enfocan en cubrir las necesidades de la misma. Estas necesidades son las que determinan el rol del centro ya que cambian por diferentes factores: sociales, económicos, de la población circundante y otros. Deben estar diseñados para transformar su rol según cambien las necesidades de la comunidad donde se sitúan.

Es también importante resaltarla promoción del desarrollo económico de la comunidad a través de la generación de empleos e ingresos para mantener en función los servicios que los centros ofrecen.




