

## **The Internet Society Announces New Appointments to Public Interest Registry Board of Directors**

**Washington, DC- 13 March 2017** -- The Internet Society today announced that Jeffrey Bedser has been appointed to the Public Interest Registry (PIR) Board of Directors. He will serve a term of three years as will returning board member Eric Burger. Hartmut Glaser is also a returning board member who will serve a term of one year. These appointments will begin at a PIR Board retreat scheduled next month.

Jeffrey Bedser is an entrepreneur with extensive private and public sector experience. He is the Chief Executive Officer of the iThreat Cyber Group and has spent decades building technology, services and solutions to combat Internet abuse and crime. Mr. Bedser is a member of the Security and Stability Advisory Council for ICANN (Internet Corporate for Assigned Names and Numbers) and serves on the Editorial Board of the Security Journal.

Returning PIR board member Eric Burger is Director of the NSF Security and Software Engineering Research Center (S<sup>2</sup>ERC) at Georgetown University. His career in technology includes roles as Chief Technology Officer at Neustar and Vice President of Engineering at BEA Systems. He has held board seats for numerous companies that have had exits, and is currently serving as a board member to two stealth startups, one in the cyber security space and one in the luxury technology space.

Hartmut Glaser is Executive Director of the Brazilian Internet Steering Committee (CGI.br). The committee coordinates and integrates all Internet services in Brazil and promotes technical quality, innovation and use of the Internet in Brazil. He also serves on the board of the Latin American and Caribbean Internet Addresses Registry.

Outgoing board member Art Reilly served on the PIR Board for two terms from 2011 to 2017. Mr. Reilly has promoted a more-inclusive Information Society and improving interoperability and quality in networks through standards for more than 25 years. He retired in April 2011 as Senior Director, Strategic Technology Policy at Cisco Systems where he was the principal representative to the International Telecommunications Union and many other UN activities on policy matters.

“We are grateful to Art Reilly for his valuable contributions and years of service to the Public Interest Registry,” said Internet Society Board of Trustees Chair Gonzalo Camarillo. “And we look forward to working with our new and returning board members, who with their diverse backgrounds, bring the knowledge and experience needed to guide the Public Interest Registry in its mission of serving the public interest online. Both the Internet Society and PIR share a vision that the Internet is a transformational force for change and we are confident these board members will help us in guiding the PIR to achieving this vision,” added Camarillo.
