The InternetNZ staff is thrilled to have the ISOC Board in Auckland and hopes that many of you will choose to stay on to attend and participate in NetHui.

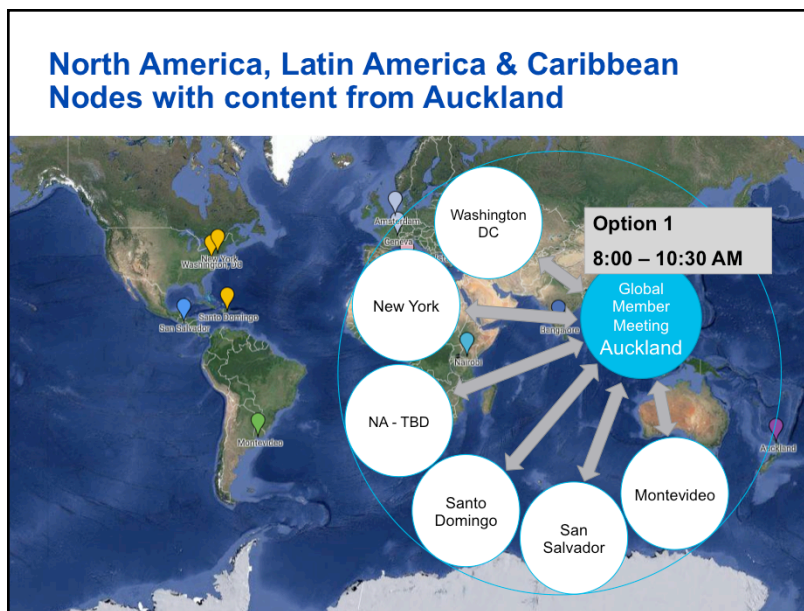
## Regional Nodes – Across the Globe

Our Regional Bureaus have identified our Node locations:

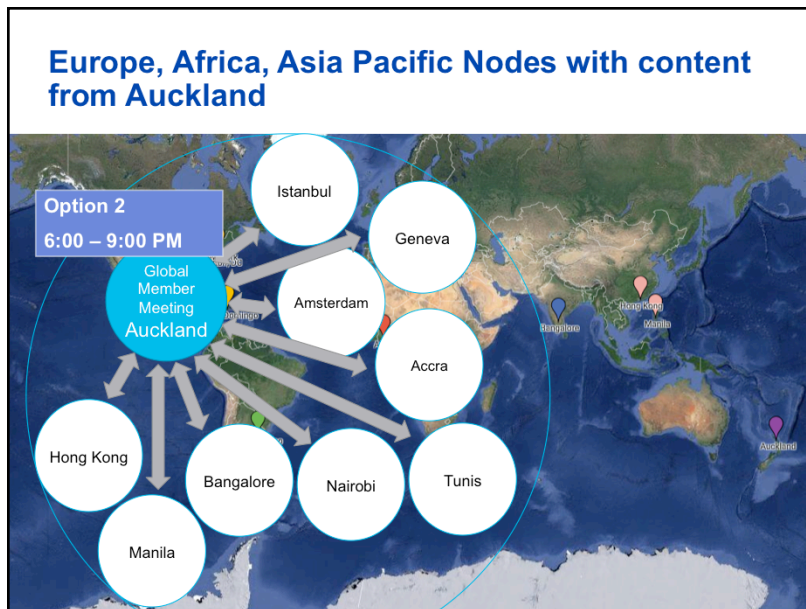
### North America

- Istanbul, Turkey

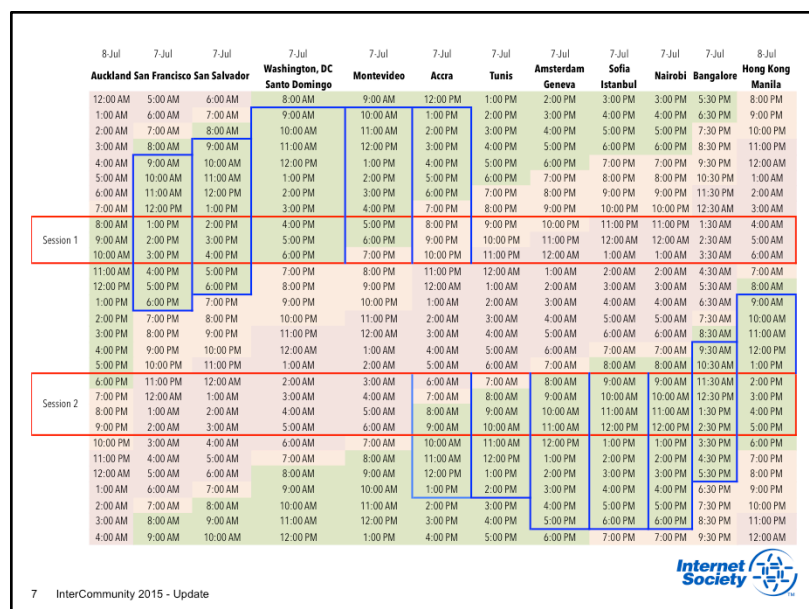
#### Africa

**InterCommunity** is a virtual event in two parts:

**1/ Global Member Meeting** featuring content from our Board of Trustees, with input from key Internet Society staff, and Regional Nodes

To ensure that we reach as much of our community as possible, we've outlined two options for the Regional Nodes to join into the Global Member Meeting:

#### Global Member Meeting, option 1 – 20:00 – 22:30 UTC on July 7

This session time is best suited for individuals and groups in the Americas. *08:00 -10:30 AM, Auckland time*

#### Global Member Meeting, option 2 – 06:00 – 09:00 UTC on July 8

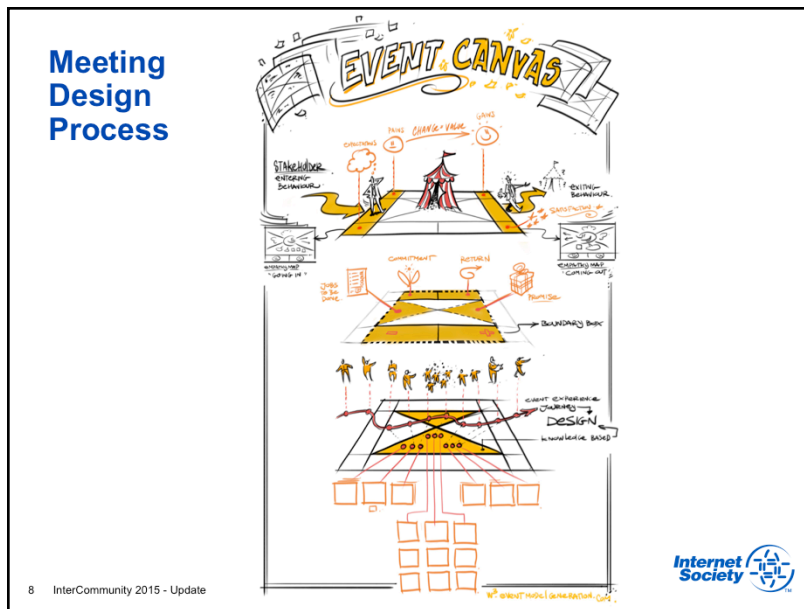
This session time is best suited for individuals and groups in Europe, Africa, and Asia Pacific. *6:00 – 9:00 PM, Auckland time*

**2/ Separately, the Regional Nodes** will host events where our local chapters and communities will come together to discuss their most relevant issues. Each Regional Node will develop their own agenda, and event timing – to suit their needs.

**As you can see from this chart**, we've attempted to visualize how the content from Auckland will overlap with the individual Regional Nodes.

The **red boxes** running horizontally show the approximate times of the Global Member Meeting content. The **blue boxes** running vertically show the approximately business hours in a given Node location – to provide examples of when their Nodes might occur.

For some Nodes (ex. those in the Americas) their events will **end** with the participation in the Global Member Meeting. For other Nodes (ex. those in Europe) their events will **begin** with participation in the Global Member Meeting.



### An Important Exercise in Meeting Design

As you recall, we are working with Ruud Janssen (collaborator on our 7 previous Chapter Workshops) to undergo an exercise in Meeting Design for the InterCommunity event.

This purposeful process allows us to create a successful event. We approach this work with a belief that **a successful event creates a change in behavior for those who attend.**

The process involves an analysis of the variety of InterCommunity Stakeholders. We looked at 8 different Stakeholder groups, including: ISOC President & CEO, Board of Trustees, ISOC Staff, Organizational Members, Regional Bureaus, Chapter Leaders, Members, and the IETF

We work to understand important factors such as their entering behavior, commitment, the event “promise”, and the ideal exiting behavior following the event.

The final outcome of this process is termed an Event Canvas – an image that works to visualize the entire event on a single page!

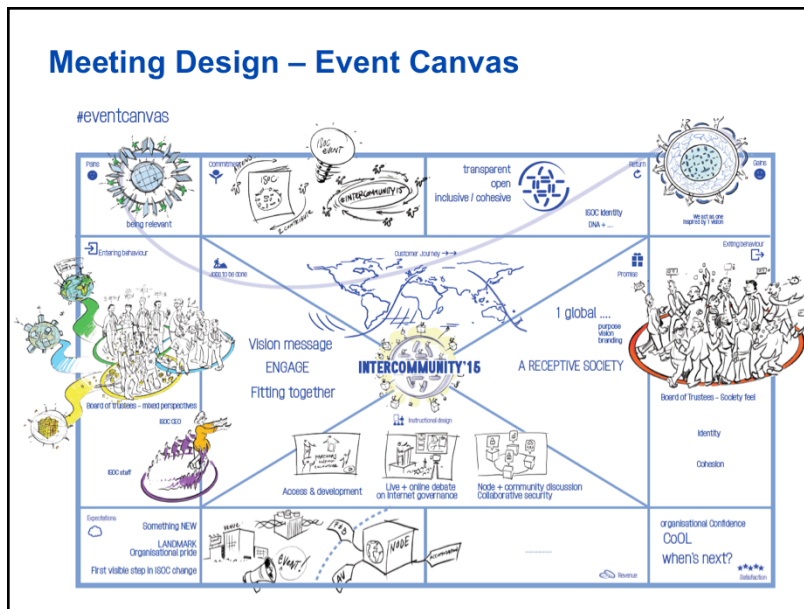




### Multi-stakeholder by Nature

What's important to note is the process of Meeting Design is multi-stakeholder by ***nature***. Throughout the process, we've involved a host of different opinions, and worked to calibrate our outcomes.

And, in a very "meta" way, we used a series of hybrid meetings to work with staff on the Meeting Design process...using a hybrid meeting to plan a hybrid meeting.



### Event Canvas – Working Draft

We are still finalizing our InterCommunity Event Canvas. This gives you a first glimpse at the *in-progress draft*.

### What's important to note

With the InterCommunity event, we hope to move our group of diverse communities together, to a common identity as a **Society**. We have differences and unique perspectives, but we come together as one, **inspired by our shared vision**.

We expect an important outcome of this process and the InterCommunity event to be a deeper understanding and appreciation of the diverse communities that make up the Internet Society – individual members, Chapter members, Organization members, the IETF, to name a few.

### A Prototype for your Participation

We've created a preliminary concept to help explain how we envision the Board participating in InterCommunity.

First it's important to note that we anticipate just **6 Trustees having speaking roles at each session**. (That is 6 for the morning session; 6 for the evening session.) We feel this lessens the burden for all. The notable exception being the Board Chair! We recommend the newly elected Board Chair to participate in both sessions.

As you review the concept, you'll note that we plan to pair Trustees with a member of the ISOC staff to cover the various topics.

**Envision if you will a Talk Show-style format.** Let's take the **Update on the Branding Effort** (proposed here @ 8:35 AM): we can picture James Wood and Narelle Clark having a lively discussion about the importance of this work, providing a status update, etc. The format would be casual, conversational, and dynamic.

This format works well across all the topics, and gives each Trustee an opportunity to shine in their area of expertise

The session would close with a Board Discussion – featuring comments and questions from the Nodes. We are already thinking hard about how to ensure engagement, participation, and involvement from not just the Nodes, but our individual remote participants as well.

## Next Steps for a successful InterCommunity

**Regional Collaboration:** We are working directly with the Global Engagement leadership team and RBDs to incorporate their insight and feedback into the development of the InterCommunity event and the local Node Events.

**Logistics:** We are in communication with the local team at InternetNZ and key vendors are being identified.

**Budget:** A preliminary budget has been developed. The budget will continue to evolve as additional aspects of the meeting are confirmed.

**Technology:** The IT Team has the lead on determining the appropriate technology for our meeting. They have identified vendors that are able to support our requirements. And, during the April 15 Q2 Community Forum we will be working with one of those vendors to test a simplified configuration.

**Community Engagement:** We will be sharing the Node locations with our wider community on 15 April – as part of the Q2 Community Forum. On Connect, an InterCommunity forum has been created and will be used to share new information with the community.
