

ITU-T Coordination Program

- ITU-T is at a crossroads on how it deals with other organizations
 - Reviewing how it handles normative references
 - Reviewing how it liaises to other organizations, and how it accepts liaisons
 - IETF is part of this review
 - Our Goal: avoid "re-specification" of our works, which would cause interoperability and safety risks, as well as potential IPR issues: <u>IAB and IESG post liaison to ITU-T TSAG</u>
- Ongoing efforts to monitor, and where possible respond appropriately to ITU-T activities regarding the IETF
 - MPLS, IPv6 Security, Web "Mashups", DPI, Security & Billing models that impact the architecture, Naming
- We are actively coordinating with other SDOs (particularly W3C and IEEE-SA) in preparation for WTSA.

Notable Events

- Update to collaboration Guidelines Approved by IAB and ITU-T TSAG
 - <u>http://tools.ietf.org/html/draft-iab-rfc3356bis</u>
- IPv6 Group concluded, with a statement that existing allocation mechanisms are sufficient (remaining activities moved to ITU-D)
- IESG approved "ACh type" for G.8113.1 upon its approval by the ITU-T
- TSB has agreed to begin sending "new-work" notices
- 3 outbound, 11 inbound liaisons

Upcoming Activities



- Russ Housley will present at ITU-T Global Standards Symposium on behalf of IETF
- ITU-T will hold its quadrennial organizational conference in November (we are monitoring for overlapping areas of interest)
- WCIT will occur directly thereafter to revise International Telecommunciation Regulations (ITRs)
- We will continue to coordinate with other interested standards organizations
