Discussion Points

- **Potential threats to the Internet Ecosystem** - The pace of government regulations in the Internet contexts has quickened.
 - **Discussion point:** *Over the next 18 months what do you see as the biggest one or two threats to an open, globally connected, secure and trustworthy Internet, from your organization's perspective?*
- **Building an Internet policy network** - The OMAC, having diverse expertise, can work together with the Internet Society to create a network of Internet policy peers.
 - **Discussion point:** *What is needed to create a network of Internet policy peers that can trust and learn from each other in order to advance their work?*
- **Gaining ground in the Internet Governance space** - The technical community is losing ground in the Internet governance space - a task that needs to be addressed collectively.

- **Discussion point:** *How can the OMAC help to further discuss with the Internet Society around a communication strategy in debunking the myth that standards bodies are controlled by certain companies?*
- **Regulatory/policy interventions** - Positive changes have been seen because of COVID-19.
 - **Discussion point:** *What were some of these positive regulatory or policy interventions that you have seen? (Example: liberalization of 6GHz in some countries, freeing up more spectrum, a focus on building more infrastructure and shift of change on how people see community networks, etc.)*
- **Event satisfaction poll results:** 36% excellent, 36% very good and 26% good.
 - **Discussion point:** *In your opinion, how can we improve the roundtables to make them 100% excellent?*
